

## HORSE UPKEEP AGREEMENT

### **Article 1**

1. The Parties agree that the subject of this Agreement is keeping the horse

### **Article 2**

1. Within the scope of costs of the horse keeping, the Provider provides:

- a) feeding 3 times a day (oat and hay), straw for bedding.
  - b) service covering bedding changing and feeding of the horse.
2. The horse may receive different nutritive fodder provided by the Customer, if it is the Customer's wish. Any vitamins and nutritional supplements are financed by the Customer.
3. Manure from bedding is owned by the Provider.

### **Article 3**

1. The Provider does not bear the responsibility for diseases or death of the horse through no fault of the Provider.
2. The Provider is not liable for damages caused by the horse during its stay.
3. The Provider has the duty to immediately inform the Customer about any diseases or injuries of the horse.

### **Article 4**

1. The Provider agrees to provide the services, which are described in article 1, at the following rates:

PLN 30 per one day + 8% of VAT

2. The Customer is obliged to pay the agreed amount of money resulting from paragraph 4.1 until 30th day of each month that the payment relates to. The amount shall be paid to the Provider's bank account:

on the basis of the invoice issued by the Provider.

**Article 5**

1. The Customer is obliged to:
- a) provide documentation confirming state of the horse health and its vaccination before accommodating it in the stable,
  - b) insure the horse at his own expense,
  - c) bear any costs of the treatment,
  - d) bear any costs of deworming, preventive vaccinations and farrier's services.

**Article 6**

The agreement is concluded for a period starting from ..... until .....

**Article 7**

1. The agreement may be terminated by either of the parties with immediate effect after clearing the previous commitments.

**Article 8**

Any and all disputes arising in connection with this agreement, which are not resolved amicably by the parties, shall be examined by the District Court, Commercial Department in Biala Podlaska (POLAND).

This agreement has been drawn up in two identical copies, one for each of the parties.
